All equipment must be turned in within seven days of the last football game or cheerleading event. There will be a pre-determined time and place for the return of equipment.

CHEERLEADING COMPETITION: Competitive Cheerleading is an available option. While there are no specific skill requirements, competing involves **extra practices and a high level of dedication and commitment**, and in order to compete an agreement must be signed. Also, additional expenses will be incurred (e.g., cheer shoes, hair bows, etc.) When the season begins, please advise your coach if your child intends to compete. An agreement will be provided at that time for signature. The MT Braves Board of Directors may, at its discretion, dismiss any girl from competition due to any infraction of the rules.
